# **National Ayush Mission**

## 19 # Smt. Sunetra Ajit Pawar:

Will the Minister of *Ayush* be pleased to state:

- (a) the status of implementation of the National Ayush Mission (NAM) in all States/Union Territories, particularly regarding the establishment and operation of Ayush Health and Wellness Centres (AHWCs);
- (b) the State-wise details of funds allocated and used under NAM since its inception, and the details of physical achievements against the targets set for each component;
- (c) the quantitative impact of NAM on public health indicators, reduction in disease burden and out-of-pocket expenditure for healthcare, especially in rural and marginalized areas; and
- (d) the steps being taken to address the alleged delays in finalizing and approving State Annual Action Plans (SAAP) under NAM?

#### **ANSWER**

# THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYUSH (SHRI PRATAPRAO JADHAV)

(a) to (d) A Statement is laid on the Table of the House.

### The Statement referred in reply to Rajya Sabha Starred Question No. 19 for 22.07.2025

- (a) Government of India is implementing the Centrally Sponsored Scheme of National Ayush Mission (NAM) through State/UT Governments and supporting their efforts for overall development & promotion of Ayush system in the country by providing financial assistance under different activities including operationalization of Ayush Health & Wellness Centres [now renamed as Ayushman Arogya Mandir (AAM) (Ayush)] by upgrading existing Ayush dispensaries as well as Sub Health Centres. Under NAM, as per the proposals received from States/UTs through SAAPs, 12500 AAM (Ayush) have been approved in different parts of the country and as reported by State/UT Governments all are operational. The State/UT-wise status of approved AAM (Ayush) is enclosed as **Annexure-I.**
- (b) Since implementation of NAM scheme comes under purview of respective State/UT Governments, no specific targets are fixed by the Government of India. However, as per the proposals received through State Annual Action Plans (SAAPs), Grant-in-aid of Rs 5670.83 crore has been released to the States/UTs from the year 2014-15 to 2024-25 for implementation of different approved activities. State/UT-wise, the status of funds allocated/released and utilization reported by the State/UT Governments under NAM from 2014-15 to 2024-25 is furnished at **Annexure-II.** Further, the major activities supported/achievements made under NAM from 2014-15 to 2024-25 is enclosed as **Annexure-III.**
- (c) The main objectives of operationalization of AAMs (Ayush) are to establish a holistic wellness model based on Ayush principles and practices, to empower masses for self-care to reduce disease burden, out of pocket expenditure (OOPE) and to provide informed choice to the needy public in the rural areas of the country. As reported by the States/UTs, footfall of the beneficiaries have been increased in the dispensaries after converting them into AAM (Ayush), as various activities & services like identification of Prakriti, Yoga, use of medicinal plants, healthy living practices, basic OPD interventions etc. are being provided. As per information received from State/UT Governments, 11.56 crore patient attended in AAM (Ayush) during 2024. Further, under NAM, State/UT Governments are also being supported for implementation of eight structured Ayush Public Health Programmes in different parts of the country including vulnerable populations in rural and underserved areas to address the problem of masses as per the potentials of Ayush health care systems in providing preventive, promotive, curative and rehabilitative health care as standalone or add on to conventional interventions.
- (d) Resource pool for the year 2025-26 had been allocated on 24.02.2025 to all States/UTs as per Budget Estimate under NAM with request to submit the State Annual Action Plans (SAAPs) by 15<sup>th</sup> March, 2025 and regular follow up was made with them. As on date, 24 States/UTs have submitted their SAAPs, out of which 12 have been finalized and remaining are under active examination towards finalization shortly. Ministry of Ayush is coordinating with the States/UTs who have not submitted their SAAPs.

# The major activities supported/achievements made under NAM from 2014-15 to 2024-25

- (i) 203 units supported for setting up of Integrated Ayush Hospitals.
- (ii) 518 Ayush Hospitals and 6234 Ayush Dispensaries have been supported for Up gradation of infrastructure and other facilities.
- (iii) 2387 Primary Health Centres (PHCs), 746 Community Health Centres (CHCs) and 319 District Hospitals (DHs) have been supported under co-location for recurring assistance of medicines and contingency on an average in each year.
- (iv) 1157 Ayush Hospitals and 12677 Ayush Dispensaries have been supported for supply of essential Ayush medicines on an average in each year.
- (v) 21 units supported for establishment of New Ayush Educational Institutions.
- (vi) 78 Under-Graduate and 46 Post-Graduate AYUSH Educational Institutes have been supported for Upgradation of infrastructure, Library and other things.
- (vii) 383 units supported for establishment of New Ayush Dispensaries.
- (viii) 1429 Ayush Grams have been supported.
- (ix) 12500 Ayush Health & Wellness Centres now renamed as Ayushman Arogya Mandir (Ayush) have been supported.
