- (b) The data on the number of Multipurpose District Mobile Ophthalmic Units established under NPCB&VI in 2025;
- (c) The data on the funding for the purchase of sophisticated modern ophthalmic equipment under NPCB&VI in 2025;
- (d) The steps taken to increase and expand research for the prevention of blindness and visual impairment under NPCB&VI in 2025; and
- (e) The details of participation of Voluntary Organisations / Private Practitioners in delivering eye care under NPCB&VI in 2025?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI PRATAPRAO JADHAV)

- (a) A total of 4,34,48,416 persons have been directly benefitted under the National Programme for Control of Blindness and Visual Impairment (NPCB&VI) during the last five years. The details are placed at **Annexure-1**.
- (b) During 2025, three (03) multipurpose district mobile Ophthalmic Units have been established under NPCBVI.
- (c) The States/UTs wise details of funding for NPCBVI is placed at **Annexure-II** including funding for the purchase of sophisticated modern ophthalmic equipment.
- (d) Under NPCBVI, indigenous cornea storage media has been developed to support cornea transplant in the country. Further, time to time National Blindness and Visual Impairment survey is conducted under NPCBVI to underpin the prevalence of blindness in the Country
- (e) As per data available on NPCBVI MIS dashboard, 2038 NGOs and 748 Private Practioners are working in the field of eye care in various States/Uts. The details are available at the weblink https://npcbvi.mohfw.gov.in/
