Promotion of Cooperative Societies in Odisha

1133 Shri Manas Ranjan Mangaraj:

Will the Minister of COOPERATION be pleased to state:

- (a) whether Government has any data on registered cooperative societies in Odisha;
- (b) if so, the number and type of such societies;
- (c) whether any special incentives are provided to tribal or women-led cooperatives in Odisha;
- (d) the amount of central assistance provided to Odisha for cooperative development in the last five years; and
- (e) the steps taken to modernize cooperative banking in rural Odisha?

ANSWER

THE MINISTER OF COOPERATION (SHRI AMIT SHAH)

- (a) & (b): Yes Sir. A comprehensive National Cooperative Database (NCD) has been developed by Ministry of Cooperation, Government of India, with the support of States / UTs. This database provides a single-point access to information on over 8.3 lakh cooperative societies across the country, comprising approximately 30 crore members. Out of these, **Odisha accounts for 7,617 cooperative societies with about 96 lakh members**. The district-wise and sector-wise details of the number of cooperative societies and their membership in the State of Odisha are enclosed as **Annexure-1** & **Annexure II** respectively.
- (c): Yes Sir. As per National Cooperative Database (NCD), there are a total of 58 Women Welfare and Tribal -SC / ST Cooperative Societies in the State of Odisha, comprising 27,626 members. National Cooperative Development Corporation (NCDC) provides 2% interest subvention on its rate of interest on term-loan portion for new and innovative activities and 1% interest subvention on its rate of interest on the term-loan portion of all activities other than new and innovative activities (in case of timely repayments) to all women cooperatives all over the country including the state of Odisha.

The details of financial assistance / grant disbursed by NCDC to tribal or women-led cooperatives in Odisha in the last 5 years is attached at **Annexure-III**.

- (d): The details of financial assistance disbursed by NCDC in the state of Odisha for cooperative development in last five years is attached at **Annexure-IV**.
- (e): The key measures undertaken by the Government to modernize cooperative banks across the country including the State of Odisha, are as follows:
 - i. RBI has permitted Urban Cooperative Banks (UCBs) to provide **door-step banking** services to their customers.
 - ii. License fee for onboarding Co-operative Banks to the modern 'Aadhaar Enabled Payment System (AePS)' has been reduced by linking it to the number of transactions.
 - iii. RBI has accorded approval to the National Federation of Urban Co-operative Banks and Credit Societies Ltd. (NAFCUB) for the formation of an **Umbrella Organization (UO)** named as *National Urban Cooperative Finance and Development Corporation Limited (NUCFDC)* for the UCB sector, which will provide necessary IT infrastructure and operation support to around 1,500 UCBs.
 - iv. To provide technological services to Rural Cooperative Banks (RCBs) and for their strengthening, RBI has given in-principal approval to NABARD for setting up of Sahakar Sarathi (Shared Service Entity).
