**INTEGRATION OF PM VISHWAKARMA YOJANA BENEFICIARIES
WITH E-COMMERCE PLATFORMS**

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the State/UT-wise number and percentage of artisans who have applied under the PM-Vishwakarma Yojana, along with the number of those who have been successfully enrolled, as on date;
- (b) status of the State/UT-wise verification completed under all stages of the scheme;
- (c) year-wise and State/UT-wise details of budgetary allocation and funds utilised;
- (d) the types of traditional trades covered and the number of beneficiaries in each of such trades; and
- (e) whether Government proposes to integrate PM Vishwakarma beneficiaries with e-commerce platforms or export facilitation channels to enhance market access and income generation, and if so, the details thereof?

ANSWER

(a): The PM Vishwakarma Scheme was launched on 17.09.2023 to provide end-to-end support to artisans and craftspeople of 18 trades who work with their hands and tools. The State/UT-wise number and percentage of artisans who have applied under the PM Vishwakarma Yojana, along with the number of those who have been successfully registered after due verification, as of 15.07.2025 is at *Annexure-I*.

(b): The State/UT-wise verification completed under all stages is at *Annexure-II*.

(c): As PM Vishwakarma is a Central Sector Scheme, State/UT-wise funds are not allocated. The details of total funds sanctioned and utilised under the Scheme are given below:

(d): The Scheme covers artisans and craftspeople engaged in 18 trades, viz. (i) Carpenter (Suthar/Badhai); (ii) Boat Maker; (iii) Armourer; (iv) Metalsmith/Metal Caster; (v) Hammer and Tool Kit Maker; (vi) Locksmith; (vii) Goldsmith (Sonar); (viii) Potter (Kumhaar); (ix) Sculptor (Moortikar, stone carver), Stone breaker; (x) Cobbler (Charmakar)/ Shoesmith/Footwear artisan; (xi) Mason (Rajmistri); (xii) Basket/Mat/Broom Maker/Coir Weaver; (xiii) Doll & Toy Maker (Traditional); (xiv) Barber (Naai); (xv) Garland maker (Malakaar); (xvi) Washerman (Dhobi); (xvii) Tailor (Darzi); and (xviii) Fishing Net Maker. The number of beneficiaries in each trade is given at *Annexure-III*.

(e): Under the scheme, PM Vishwakarma beneficiaries across the country are being provided with marketing support including participation in trade fairs, state level exhibitions etc. to showcase, display and sell their handicrafts. Also, online marketing support is being provided to PM Vishwakarma beneficiaries through various e-commerce platforms to promote online sale of their products.
