THE DETAILS OF THE PNG SUPPLY NETWORK IN THE COUNTRY

149 DR. M. THAMBIDURAI:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

(a) the details of the Piped Natural Gas (PNG) supply network currently set up in the country during the last five years and the current year, State -wise;

(b) whether it is a fact that the PNG supply has not been set up so far in the State of Tamil Nadu;

(c) if so, the details thereof and the reasons therefor;

(d) By when-the PNG will be supplied to domestic consumers in the State of Tamil Nadu; and

(e) further steps taken by Government in this regard?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS

(SHRI SURESH GOPI)

(a) Providing Piped Natural Gas (PNG) connections and laying of pipeline infrastructure is part of development of City Gas Distribution (CGD) Networks and the same is carried out by the entities authorized by Petroleum and Natural Gas Regulatory Board (PNGRB) as per their Minimum Work Programme (MWP).

PNGRB has authorized entities for the development of CGD network in 307 Geographical Areas (GAs), covering almost 100% of the mainland area (except islands) for the development of CGD network across the country. As per MWP target, authorized entities have to provide approx. 12.6 crore PNG connections and 5.46 lakh inch-km pipeline by 2034. As on 31.5.2025, the authorized entities have provided 1.52crore PNG Domestic (PNG (D)) connections and laid 5.98 lakh inch-Km pipelines.

The cumulative details of the progress of Piped Natural Gas Domestic [(PNG)D] across the country, state-wise, in the last five years and current year is at **Annexure**.

(b) to (e) PNGRB has authorized 18 Geographical Areas (GAs) including (1 GA spread over Puducherry (UT) & Tamil Nadu and 1 GA spread over Andhra Pradesh, Tamil Nadu and Karnataka), in the state of Tamil Nadu with Minimum Work Programme (MWP) target of 2,30,94,884 domestic PNG connections to be provided by 2032. As on 31.05.2025, the authorised entities have provided 98,878 PNG(D) Connections.

Government has taken various steps to ensure the availability of Natural Gas to PNG (Domestic) sector which includes allocating domestic gas on priority basis to CNG (T)/PNG (D); diverting domestic gas from non-priority sectors to meet the requirement for CNG (T)/PNG (D) sector, expansion of City Gas Distribution (CGD) network, expansion of National Gas Grid Pipeline, setting up of Liquefied Natural Gas (LNG) Terminals, Sustainable Alternative Towards Affordable Transportation (SATAT) initiatives to promote Bio-CNG, etc. Government has also notified that gas produced from discoveries in Deepwater, Ultra Deepwater and High Pressure-High Temperature areas, in any situation which may require proportionate distribution of the gas offered under the bidding process, the contractor shall offer gas to bidders belonging to CNG (T)/PNG (D) sector on priority.
