STATUS AND APPRAISAL TIMELINE OF OIL BLOCKS IN WEST BENGAL

151. SHRI SAMIK BHATTACHARYA:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state: -

- (a) the current status of oil exploration and development at the Asokenagar-2, Kankpul-1, Bhurkunda-1, and Ranaghat-2 oil blocks in the State of West Bengal;
- (b) the expected timeline for the completion of the appraisal phase for each of these blocks;
- (c) the hydrocarbon volume estimates for these blocks and whether any preliminary assessments have been made;
- (d) the details of ONGC's acreage holding in the State of West Bengal under OALP Blocks BP-ONHP-2018/1, BP-ONHP-2019/1, BP-ONHP-2019/2, and BP-ONHP-2021/1, covering North & South 24 Parganas, East & West Midnapore, Nadia, Murshidabad, and Burdwan districts; and
- (e) the specific exploration activities planned for these blocks?

(a) to (c):The current status and Appraisal timeline of oil exploration and development of Asokenagar-2, Kankpul-1, Bhurkunda-1, and Ranaghat-2 of oil and gas blocks falling in NELP-VII Block WB-ONN-2005/4, operated by ONGC in West Bengal is as follows:

The recoverable hydrocarbon reserves based on preliminary assessment (2P, EUR) for the Block WB-ONN-2005/4 are estimated to be 0.98 million metric tonne of oil equivalent (MMTOE).
