COAL BLOCKS IN ECO-SENSITIVE ZONES

1635 SMT. RANJEET RANJAN:

Will the Minister of **COAL** be pleased to state:

- (a) whether it is a fact that the coal blocks auctioned by Government since 2014 are located in eco-sensitive zones, forest areas, or wildlife corridors;
- (b) if so, the number and names of such blocks, and whether environmental and forest clearances were obtained prior to allocation;
- (c) whether Government has considered the long-term ecological risks and biodiversity loss associated with mining in such regions, and whether any blocks were withdrawn from auction on these ground; and
- (d) whether Government is working in consultation with other departments to balance coal extraction targets with India's clean energy transition goals?

ANSWER

**MINISTER OF COAL & MINES
(SHRI G. KISHAN REDDY)**

(a) & (b) None of the coal blocks auctioned by the Government since 2014 are located within notified Eco-Sensitive Zones or Wildlife Corridors. However, several of the auctioned coal blocks fall within areas having forest cover. A list of auctioned coal blocks is enclosed at ***Annexure - I***.

Further, it is to state that the responsibility to obtain all necessary statutory clearances, including Environmental Clearance (EC) and Forest Clearance (FC), lies with the allottee after the allocation of the coal block. However, in accordance with the provisions of the Coal Mines (Special Provisions) Act, 2015, clearances (including EC and FC), if available, are vested in favour of the allottee.

(c) Yes, the Government undertakes a comprehensive evaluation of long-term ecological risks and potential biodiversity loss before permitting mining operations in sensitive areas. Further, in some cases coal blocks have been withdrawn from the auction process on these grounds.

(d) Yes, the Ministry of Coal is working in close coordination with relevant Ministries and Departments, including the Ministry of Power, Ministry of New & Renewable Energy (MNRE), NITI Aayog, and Ministry of Environment, Forest & Climate Change (MoEF&CC), to ensure a balanced approach towards energy security and clean energy transition.
