**PM VISHWAKARMA SCHEME IMPLEMENTATION IN KARNATAKA**

1691. SHRI NARAYANA KORAGAPPA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether it is a fact that 31.48 lakh applications has been received under PM Vishwakarma Scheme from the State of Karnataka, if so, the details thereof, district-wise;
- (b) whether Central Government has approved 5.5 lakh registrations out of above 31.48 lakh from the State of Karnataka, if so, the details of registrations thereof, district-wise;
- (c) the details of artisans given basic training out of 5.5 lakh and artisans who have been sanctioned loan till June, 2025; and
- (d) the efforts being made to register more and more artisans under PM Vishwakarma Scheme from the State of Karnataka?

**ANSWER**

(a) to (c): The PM Vishwakarma Scheme was launched on 17.09.2023 to provide end-to-end support to artisans and craftspeople of 18 traditional trades who work with their hands and tools. As of 29.07.2025; 32.26lakh applications have been received in the state of Karnataka under PM Vishwakarma out of which 5.72lakh beneficiaries have been successfully registered after three stage verification. District-wise details of Applications received, successful Registrations, Basic Training completed and Loans sanctioned to Vishwakarma beneficiaries in the State of Karnataka are at **Annexure-I**.

(d): Ministry of Micro, Small and Medium Enterprises (MSME) has conducted various outreach programmes, trade fairs and State-level exhibitions throughout the country, including state of Karnataka, to spread awareness about the benefits of PM Vishwakarma Scheme. Further, mass media outreach through broadcast of radio jingles is done to conduct awareness about the scheme.
