DMF IN THE STATE OF JHARKHAND

1700 # SHRI ADITYA PRASAD:

Will the Minister of MINES be pleased to state:

- (a) the details of the funds collected, approved and spent under District Mineral Foundation (DMF) in various regions, particularly in the State of Jharkhand, district-wise;
- (b) the number of complaints received under grievance redressal mechanism so far and the status of their disposal;
- (c) whether the process of including elected representatives in the Governing Councils has been implemented uniformly in all the concerned districts;
- (d) if so, the details thereof; and
- (e) whether any Tribes Advisory Council or Gram Sabhas have opposed the use of DMF funds and the action taken by Ministry in this regard?

ANSWER

- (a) As per the information received from the State Government of Jharkhand, the details are given at Annexure-I.
- (b) The Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) Guidelines 2024 stipulates that the DMFs shall devise and implement a grievance redressal mechanism so that each grievance is redressed within the stipulated time frame. As per the information received from the State Government of Jharkhand, there is no publicly available centralized data specifically detailing the number of complaints received and disposed under the grievance redressal mechanism related to DMFs.
- (c) & (d) As per the information received from the State Government of Jharkhand, the inclusion of elected representatives in the Governing Councils has been implemented uniformly across all districts.
- (e) As per the information received by the State Government of Jharkhand, there is no concerns and opposition from Tribes Advisory Council or Gram Sabhas regarding the use of District Mineral Foundation (DMF) funds in Jharkhand.
