GAS SUPPLY THROUGH PIPELINE TO EVERY HOUSE IN MP

1720 # SMT. MAYA NAROLIYA:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) the number of households provided with Piped Natural Gas (PNG) connections so far in various districts of Madhya Pradesh connected to City Gas Distribution (CGD) network, district-wise figures and details thereof;
- (b) whether the Central Government has started supply of natural gas through pipeline to government residential complexes and defence units situated in the State of Madhya Pradesh, if so, the details of their location; and
- (c) the amount of natural gas allocated for domestic use to CGD network in the State of Madhya Pradesh for the year 2024-25

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF PETROLEUM AND NATURAL GAS

(a) to (c) Providing Piped Natural Gas (PNG) connections are part of the development of City Gas Distribution (CGD) Network and the same is carried out by the entities authorized by Petroleum and Natural Gas Regulatory Board (PNGRB) as per their Minimum Work Programme (MWP). PNGRB has authorized 25 GAs (including 2 GAs spread over Madhya Pradesh and Rajasthan, 1 GA spread over Madhya Pradesh and Uttar Pradesh, 1 GA spread over Madhya Pradesh and Chhattisgarh & 1 GA spread over Maharashtra and Madhya Pradesh) covering the entire state of Madhya Pradesh. As on 31.05.2025, the authorized entities have provided more than 2.93 lakh PNG Domestic (PNG (D)) connections as against the MWP target of about 65.22 lakh (to be achieved by 2031).

The GA wise details of domestic PNG connections in the State of Madhya Pradesh as on 31.05.2025 is at **Annexure**.

The authorized entities have also extended PNG connectivity to Government residential complexes and Defence establishments/units as part of the CGD network expansion (including in the State of Madhya Pradesh). As on 31.05.2025, PNG connections have been provided to more than 540 households in Government residential complexes and Defence units situated in the State of Madhya Pradesh.

On an average ~63000 Standard Cubic Meter per Day (SCMD) of natural gas was allocated to domestic PNG segment of CGD Sector in Madhya Pradesh during FY 2024-25.
