## AVAILABILITY OF FERTILIZER STOCK

Will the Minister of **CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) the total available stocks of chemical fertilizers in the country as on 1st April, 2025 and whether the volume has dropped compared to the previous year;
- (b) whether it is a fact that the available stocks of chemical fertilizers in the country as on 1st April, 2025 is at the 3-year-low, if so, the reasons therefor; and
- (c) whether the demand for chemical fertilizers for 2025 Kharif season is expected to be higher compared to the last year, if so, the total expected demand and whether Government has adequate stock of fertilizers as on date to meet this demand?

(a) & (b) The information regarding available stocks of chemical fertilizers viz. Urea, DAP, MOP and NPKS in the country as on 1<sup>st</sup> April, 2025, along with the corresponding data for the previous three years, is provided below:
