AB-PMJAY IN KARNATAKA

1887. SHRI LAHAR SINGH SIROYA:

Will the **Minister of HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the number of people in Karnataka, benefited from the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana(AB-PMJAY), year-wise and district-wise;
- (b) whether it is a fact that free treatment for senior citizens aged 70 and above, under the Ayushman Vay Vandana card scheme, is still elusive in Karnataka;
- (c) if so, the details thereof; and
- (d) the details of steps taken to ensure comprehensive implementation of the scheme in the State?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SHRI PRATAPRAO JADHAV)

- (a): The year-wise and district-wise details of number of hospital admissions authorized under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) in the State of Karnataka are at **Annexure**.
- (b) and (c): In October 2024, the government expanded AB-PMJAY to provide free treatment benefits of up to ₹5 lakh per year to approximately 6 crore senior citizens aged 70 years and above, belonging to 4.5 crore families, irrespective of their socio-economic status, through Vay Vandana cards. State Health Authorities of the implementing States/UTs are the nodal agencies responsible for onboarding and implementation of the scheme in their respective States/UTs.
- (d): AB-PMJAY has a comprehensive media and outreach strategy to spread awareness and empower beneficiaries for their rights and entitlements. This includes advertisement over traditional media platforms including newspapers, community radio, street plays, digital displays, radio campaigns, mass messaging, telecast of beneficiary testimonials via Doordarshan, etc. In addition to this, State Health Agencies have also engaged the wide

network of frontline workers i.e., ASHAs, AWWs and VLEs (Village level Entrepreneurs) who are pivotal in creating mass awareness at the grassroot level. In addition to this, beneficiaries can call to 24x7 call centre (14555) for any assistance/queries.

Under AB-PMJAY, the health benefit packages have been revised and rationalized five times since the launch of the scheme. Health Benefit Package (HBP) 2022 comprises of 1,961 procedures across 27 medical specialties.

Regular review and monitoring of the scheme is done through a dashboard, which is used to objectively assess the scheme's performance in terms of metrics such as the number of cards issued, hospital admissions, quality of treatment provided and timely settlement of claims. In addition to this regular review meetings are organized with States/UTs to assess scheme's implementation.
