STATUS OF PM-KUSUM SCHEME IN UTTAR PRADESH

will the minister of new and renewable energy be pleased to state:

- (a) the progress made so far under the Pradhan Mantri Kisan Urja Suraksha Evam Utthaan Mahabhiyan (PM-KUSUM) scheme in Uttar Pradesh, district-wise;
- (b) the details of demands received and fund allocation made to Uttar Pradesh under the said scheme during the last five years; and
- (c) the amount of financial assistance provided to the farmers of Uttar Pradesh under the scheme, the details thereof, component-wise and district-wise during the last five years?

ANSWER

(a) PM-KUSUM is a demand driven scheme. The capacities are allocated based on demand received and progress shown by the States/UTs. The component-wise capacity sanctioned and installed in the State of Uttar Pradesh, till 30.06.2025, is as under:

The district wise installation under PM-KUSUM scheme, as reported by SIAs of Uttar Pradesh is at **Annexure I**.

(b) & (c) In the PM KUSUM scheme, fund allocation is based on the progress made by the states against the allocated capacities. The details of central and state financial assistance available under the Scheme are annexed at **Annexure II**.

As on 30.06.2025, a total of Rs 398.24 Crore was released to the state of Uttar Pradesh during last five financial years, which includes Rs 362.26 Crore under Component B and Rs 35.98 Crore under Component C (IPS). No claim has been raised by the state for Component A and Component C (FLS).

**Financial Assistance for various Components including Solar Plants under PM-
KUSUM Scheme**

Components, Targets & Criteria	Financial Assistance available
Component A:	Procurement Based Incentive (PBI) is provided to the DISCOMs @ 40 paise/kWh or Rs.6.60 lakhs/MW/year, whichever is lower, for five years. There is no CFA under this Component.
Component B	<ul style="list-style-type: none"> • CFA of 30% of the benchmark cost issued by MNRE or the prices of the systems discovered in the tender, whichever is lower is provided.
Component C (Individual Pump Solarisation)	<ul style="list-style-type: none"> • However, in North Eastern States including Sikkim, Jammu & Kashmir, Ladakh, Himachal Pradesh and Uttarakhand, Lakshadweep and A&N Islands, CFA of 50% of the benchmark cost issued by MNRE or the prices of the systems discovered in the tender, whichever is lower, is provided. • In addition, the respective state/UT has to provide at least 30% financial support. Balance cost is to be contributed by beneficiary. • Component B and Component C (IPS) of PM KUSUM scheme can also be implemented without State share of 30%. The Central Financial Assistance will continue to remain 30% and rest 70% will be borne by the farmer.
Component C (Feeder Level Solarisation)	For agriculture feeder solarization, CFA of Rs 1.05 Crore per MW is provided. There is no mandatory requirement of financial support from participating State/UT. The feeder solarisation can be implemented in CAPEX or RESCO mode.
