DEVELOPMENT OF SPORTS INFRASTRUCTURE IN MAHARASHTRA

2236 SHRI DHANANJAY BHIMRAO MAHADIK:

Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state :-

- (a) the current status of sports infrastructure projects in Maharashtra, including stadiums, training centres, and sports complexes;
- (b) the funds allocated and utilized for these developments in the last three years;
- (c) the measures taken to ensure accessibility for rural and urban youth; and
- (d) the plans to upgrade existing facilities to international standards?

ANSWER

(a) to (d) 'Sports' being a State subject, the responsibility of development of sports, including allocating and utilizing funds for development of sports infrastructure such as stadiums, training centres, and sports complexes, ensuring accessibility of such sports facilities to both rural and urban youth and upgrade the existing sports infrastructure in the State to meet international standards, rests primarily with the respective State/Union Territory Governments. The Union Government only supplements their efforts by bridging critical gaps. The details of various sports infrastructure across the country, which are under the jurisdiction of respective State/Union Territory Governments, are not maintained in this Ministry. The details of the sports infrastructure projects approved and their sanctioned cost, funds released and their physical and financial progress, under Khelo India Scheme and National Sports Development Fund (NSDF), across the country, including in the State of Maharashtra, are available in public domain on the dashboards of the Ministry at https://mdsd.kheloindia.gov.in and http://www.nsdf.yas.gov.in/nsdf-glance.html. The details of Sports Authority of India (SAI) Training Centres (STCs) across the country are available at https://sportsauthorityofindia.nic.in/sai_new/sai-training-center.

Funds are allocated and released Scheme-wise and not State-wise in this Ministry. The details of funds allocated and expenditure incurred under various Sports Development Schemes of the Department of Sports across the country, including for development of stadiums, training centres and sports complexes, during the last three years are as under:

The sports facilities supported under these schemes are available to all citizens of the country, including rural and urban youth.

The Khelo India Scheme and National Sports Development Fund (NSDF), implemented by this Ministry, under which financial assistance for development of sports infrastructure is provided, are demand-driven schemes. The proposals received from the State/UT Governments and other eligible entities are considered for financial support, subject to their completeness, technical feasibility and availability of funds under the Scheme. No specific plan for upgradation has been formulated by the Ministry for the State; assistance is extended as per the provisions of these schemes based on proposals received.
