#### BENEFICIRIES AND AMOUNT TRANSFARRED UNDER PM-KISAN IN KARNATAKA

2242. SHRI LAHAR SINGH SIROYA:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the number of farmers from Karnataka who have benefited from Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) scheme since 2020;
- (b) the total amount transferred to beneficiaries in the State so far; and
- (c) whether Government plans to expand the scheme to include tenant farmers and sharecroppers?

#### **ANSWER**

THE MINISTER OF STATE FOR AGRICULTURE AND FARMERS WELFARE (SHRI RAMNATH THAKUR)

(a) & (b): The PM-KISAN scheme is a central sector scheme launched in February 2019 by the Hon'ble Prime Minister to supplement the financial needs of farmers with cultivable land-holding. Under the scheme, a financial benefit of Rs 6,000/- per year is transferred in three equal instalments, into the Aadhaar seeded bank accounts of farmers through Direct Benefit Transfer (DBT) mode.

A farmer-centric digital infrastructure has ensured that the benefits of the scheme reach all eligible farmers across the country without involvement of any intermediaries. Maintaining absolute transparency in registering and verifying beneficiaries, as on 04.08.2025, the Government of India has disbursed over Rs 3.90 lakh Cr to farmers in 20 installments since inception of the Scheme.

The instalment-wise details of benefits released under PM-KISAN in the State of Karnataka since FY 2020-21 is attached at Annexure.
