(a) to (d) The details of country's International Merchandise Export and Import for 31 Major Commodities compiled for the period Apr-Jun of current financial year 2025-26 are attached at Annexure I. The data relating to India's Merchandise export and import is available on DGCI&S' Data Dissemination Portal (Link-https://ftddp.dgciskol.gov.in/dgcis/).

Based on RBI's data, services exports were US\$ 341.1 billion in 2023-24. RBI does not compile state-wise services export figures.
