MEGA FOOD PARK AND PMFME SCHEME FOR PRIVATE COMPANIES, STARTUPS AND COOPERATIVES IN BIHAR

2307. DR. BHIM SINGH:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) whether Government is providing financial assistance and technical guidance to private companies, startups and cooperatives involved in the food processing sector in Bihar through Mega Food Park, Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) scheme or other means; and
- (b) if so, the district-wise and scheme-wise details of the beneficiaries and assistance provided along with the approved list of projects and grants distributed so far?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a) & (b): In order to boost and ensure overall development of Food Processing Industries, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of related infrastructure through its two Central Sector Schemes namely Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) and Production Linked Incentive Scheme for Food Processing Industry (PLISFPI). Mega Food Parks, a component scheme under PMKSY, has been discontinued with effect from 01.04.2021.

MoFPI is also implementing Centrally sponsored scheme namely PM Formalization of Micro Food Processing Enterprises (PMFME) scheme for providing financial, technical and business support for upgradation/setting up of micro food processing enterprises.

All the three schemes are not region specific but demand driven and are implemented across the country including Bihar. Ministry provides subsidy/incentives to the eligible applicants including private companies, startups and Cooperatives under these schemes.

The details of food processing projects approved by MoFPI under the said three schemes in the State of Bihar is at **Annexure.**
