SCHEMES FOR DEVELOPMENT OF FOOD PROCESSING INDUSTRIES

2308. SHRI G.C. CHANDRASHEKHAR:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- (a) the details of all schemes available for development of food processing industries;
- (b) whether the said schemes are available to private entrepreneur/cooperatives and if so, the details thereof; and
- (c) the details of the ongoing schemes in the food processing sector in Karnataka, district-wise?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI RAVNEET SINGH)

(a) to (c): In order to boost and ensure overall development of Food Processing Industries, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of related infrastructure through its two Central Sector Schemes namely Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) and Production Linked Incentive Scheme for Food Processing Industry (PLISFPI). Further, Centrally sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) is also being implemented by MoFPI. All the three schemes are not region specific but demand driven and are implemented across the country including all districts of Karnataka.

Ministry provides subsidy/incentives to the eligible applicants including private Entrepreneurs and Cooperatives under these schemes.

The details of food processing projects approved by MoFPI under the said three schemes in the State of Karnataka is at **Annexure.**
