RDSO STAFF DEPLOYMENT FOR LOCAL TRAIN SERVICES IN MUMBAI DIVISION

2367 DR. MEDHA VISHRAM KULKARNI:

Will the Minister of RAILWAYS be pleased to state:

- (a) whether local train services between Kalyan-Nashik Road and Kalyan-Pune have been sanctioned but are delayed due to pending feasibility tests;
- (b) if so, whether the absence of Research Design and Standard Organization (RDSO) staff is the primary reason for the delay;
- (c) whether stabling issues at Kalyan have led to Nashik Road being considered as an alternative; and
- (d) the steps being taken to ensure RDSO staff attendance for timely implementation of these services?

(a) to (d) The width of the local trains in Mumbai area is more than other passenger trains. There are dimensional limitations in tunnels on Kasara-Igatpuri ghat section and Karjat-Lonavala section due to which, operation of EMU local trains is not possible in these sections at present.

There is no role of Research Designs & Standards Organization (RDSO) on this issue.

However, Kalyan-Kasara-Nasik Road sector is presently served by 132 Mail/Express services, while Kalyan-Karjat-Pune sector is served by 120 Mail/Express services. Further, Kalyan-Kasara sector is also served by 36 Sub-urban services, while Kalyan-Karjat sector is served by 70 Suburban services.

Besides, introduction of new train services, including sub-urban services, is an on-going process on Indian Railways, subject to traffic justification, operational feasibility, availability of resources, etc.

Presently, Kalyan-Nashik Road section (134 km) is a double line section except Kasara-Igatpuri which is 3 line section. Work of 3rd line between Kalyan-Kasara (67 Km) has been taken up. Further, Survey for 4th line between Kasara- Asangaon (35 Km) and multitracking of Kasara- Nashik Road Manmad (131 Km) has been sanctioned for preparation of Detailed project Report (DPR).

Similarly, of the 137 Km route length of Kalyan-Pune section, 27 Km is 3 line section and balance 110 Km is double line rail section. Surveys for construction of 3rd & 4th line between Badlapur-Karjat (32 Km) and 4th & 5th line between Karjat-Lonavala (27 Km) and Lonavala-Pune (64 Km) have been sanctioned for preparation of Detailed project Report (DPR).
