**INCLUSION OF SLUMS/UNAUTHORIZED SETTLEMENTS IN SMART CITY SCHEME**

**2443. SHRI SANDEEP KUMAR PATHAK:**

**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) whether in many States, slums/unauthorized colonies have been kept out of the ambit of Smart City & AMRUT schemes, if so, the reason therefor, if not, a list of Smart City-wise number of unauthorized colonies/slums, number of houses and population in them; and
- (b) whether any clear cut plan has been made to include basic services like water supply-drainage etc., in these settlements, if so, the State-wise details of amount received from centre for these works during the last three years and the percentage-wise quantum of this amount out of the total amount fixed for Smart City project, the State-wise details thereof?

**ANSWER**

- (a) & (b): Smart Cities Mission (SCM) was launched on 25.06.2015. The Central Government has a total outlay of ₹48,000 crore for the 100 cities covered under SCM. The Mission followed an area-based development approach through retrofitting, redevelopment and greenfield development in 100 cities. The cities under SCM are being developed based on Smart City Proposals (SCPs) received from States/UTs, across various sectors, viz., smart mobility, Water, Sanitation, Hygiene (WASH), smart governance, smart energy, environment etc., approved by High Powered Steering Committee (HPSC). Sector wise details of projects under SCM is at Annexure-I.

Atal Mission for Rejuvenation and Urban Transformation (AMRUT) was launched in the year 2015 in 500 cities (485 cities including 15 merged cities) across all States/UTs in the country. The major thrust areas of the Mission were water supply, sewerage & septage management, storm water drainage, green spaces & parks, non-motorized urban transport. AMRUT 2.0 scheme was launched in the year 2021, in all Urban Local Bodies (ULBs)/ cities, enabling the cities to become 'self-reliant' and 'water secure'. Providing universal coverage of sewerage & septage management in 500 AMRUT cities is one of the major focus areas of AMRUT 2.0. Rejuvenation of water bodies, development of green spaces and parks are other components of the Mission. Central allocation and funds released during last three years, State-wise under AMRUT & AMRUT 2.0 is given in Annexure-II and Annexure-III respectively.

Under AMRUT, households in informal settlements/ slums within the ULBs/ cities are covered under the Mission. States/UTs are empowered to select, appraise, prioritize and implement the projects within the broad framework of Mission guidelines.
