EVALUATION OF URBAN WATER RESILIENCE AND INFRASTRUCTURE STRENGTHENING UNDER AMRUT 2.0

2476. SHRI SADANAND MHALU SHET TANAVADE:

Will the Minister of Housing and Urban Affairs be pleased to state:

- (a) the total funds allocated, released, and utilised so far under AMRUT 2.0 since its launch in 2021, with a State/UT-wise breakup;
- (b) the number of cities and towns where work has commenced and the proportion that have achieved universal household tap connections, sewerage network expansion, and septage treatment coverage, with a State/UT-wise breakup;
- (c) the measurable impact of the programme on urban water resilience and climate-adaptive infrastructure; and
- (d) whether any third-party audits or outcome assessments have been undertaken to evaluate effectiveness, and if so, their findings?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

- (a) Under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0, against allocated Central share of ₹66,750 crore for projects for the entire Mission period, ₹16,798.73 crore have been released/sanctioned so far. The States have submitted Utilization Certificate worth ₹8,601.12 crore. State/UTs wise funds allocated, released/ sanctioned and utilized under AMRUT 2.0 are given in Annexure-I.
- (b) & (c) Under AMRUT 2.0, States/UTs are empowered to select, prioritise, design, implement and monitor the projects within the broad framework of Mission guidelines. So far, under AMRUT 2.0 a total of 8873 projects in 3,358 Urban Local Bodies (ULBs)/ cities as submitted by the States/ Union Territories (UTs) worth ₹1,94,172.99 crore, have been approved by the Ministry of Housing and Urban Affairs, which include 3,571 water supply projects worth ₹1,18,421.92 crore, 586 Sewerage and Septage Management projects worth ₹68,461.78 crore, 3,032 water body rejuvenation projects worth ₹6,210.66 crore and 1,684 parks projects worth ₹1,078.63 crore. As reported by the States/ UTs as on 14.07.2025, under AMRUT 2.0, approved projects cover provision of 178 lakh new water tap connections and 69 lakh new sewer connections and development of 36,761 acres of permeable green space.

As reported by the States on AMRUT 2.0 portal (as on 14.07.2025), States/ UTs have grounded 6131 projects worth ₹1,08,244.60 crore in 2858 ULBs/ cities, of which works worth ₹42,027.85 crore have been physically completed. State/UTs wise progress of water supply and sewerage and septage management projects under AMRUT 2.0 are given in Annexure II.

(d) NITI Aayog had conducted a review in June 2020 on the evaluation of Centrally Sponsored Schemes in the Urban Transformation Sector, including AMRUT. The study assessed key parameters such as coverage, incorporation of universal design, gender mainstreaming, pro-poor design, migration, and beneficiary targeting. The performance under the scheme was reported satisfactory as it aims to improve the quality of life of all including the poor and disadvantaged. Further, for assessment and monitoring of work done under AMRUT in the States/ UTs, there is a provision of Independent Review and Monitoring Agencies (IRMAs). Also, in order to fast-track the implementation of AMRUT 2.0, the progress is periodically reviewed and monitored through regular video conferences/ webinars/ workshops/ site-visits etc. by Ministry of Housing and Urban Affairs (MoHUA) with the States/ UTs and ULBs. There is a dedicated AMRUT 2.0 online portal for tracking progress and project-wise outcomes.
