Will the Minister of *Corporate Affairs* be pleased to state:

- (a) the number of youths who have completed their profile on the portal as on date for the State of Bihar under the Pradhan Mantri Internship Scheme (PMIS) announced in the Budget 2024-25, district-wise;
- (b) the number of youths in the State offered internships by top 500 companies or other partner companies as on date, the details thereof, State-wise and company-wise; and
- (c) whether government is taking any special initiative to increase internship opportunities under the PMIS scheme in the State of Bihar, if so, the details thereof?

**ANSWER**

(a): The Prime Minister Internship Scheme (PMIS) was announced in the Budget 2024-25. It aims to provide internship opportunities to one crore youth in top 500 companies in five years. As an initiation to this scheme, a Pilot Project of the scheme targeted at providing 1.25 lakh internship opportunities in one year has been launched on 03.10.2024.

The total number of candidates from the state of Bihar, who have completed their profiles and registration process on the portal is over 22,700 in Round I and over 19,900 in Round II.

District wise details of candidates who have completed their profiles on the portal from different districts of Bihar in round I and round II of the PMIS pilot project, is attached at Annexure I.

(b): In the round I of the pilot project, which commenced from 3rd October, 2024, more than 1.27 lakh internship opportunities were posted by the partner companies across the country. Over 82,000 internship offers were made by the companies, to over 60,000 candidates in this round.

In the round II of the pilot project, which commenced on 9th January, 2025, the partner companies have posted over 1.18 lakh internship opportunities (new and edited unfilled opportunities of previous round) across the country. As on 07.08.2025, over 79000 internship offers were made by the companies, to over 67,500 candidates. Currently, rolling out of offers and the process of acceptances/ joining by interns is in progress.

The state wise details of the number of youths to whom offers were made in round I and round II of the pilot project is enclosed at Annexure II.

Further, company-wise details of the number of youths to whom offers were made by the companies in Round I and Round II of the pilot project is enclosed at Annexure III and Annexure IV respectively.

(c): The Ministry of Corporate Affairs is actively working with various stakeholders such as state governments, central government ministries & departments, and industry associations for promotion and implementation of the scheme. In the state of Bihar, MCA has actively collaborated with the state government to carry out extensive Information, Education and Communication activities, including workshops, seminars, and promotional campaigns - both online and on-ground to amplify program visibility and to reach out to the target groups in various districts of the State. With active support from Nodal Department, awareness campaigns were carried out at ITIs, Diploma, degree, and graduate colleges. The Nodal Department is also providing support in monitoring the implementation of the Pilot Project on a regular basis.
