AMOUNT DISBURSED UNDER PRADHAN MANTRI MUDRA YOJANA

2616 # SHRI NEERAJ DANGI:

Will the Minister of **FINANCE** be pleased to state:

- (a) the amount distributed so far, especially in Rajasthan, under the Pradhan Mantri Mudra Yojana for providing self-employment opportunities in the country, in the last five years district wise;
- (b) district wise details of the loans provided to Scheduled Castes/Scheduled Tribes and women especially in the State of Rajasthan during the last three years; and
- (c) whether cognizance has been taken about the cases of fraud in providing loans under the said scheme and bank-wise details of complaints received in respect of loans given by banks to needy people?

ANSWER

(a): As on March, 2025, more than Rs. 21.68 lakh crore have been disbursed under Pradhan Mantri Mudra Yojana (PMMY) across the country in last five years. Of these, more than Rs. 1.13 lakh crore have been disbursed in the state of Rajasthan.

District wise disbursement under the Scheme for the state of Rajasthan is placed at Annexure-I.

(b): The district wise detail of the PMMY loans provided to Scheduled Castes/Scheduled Tribes and women in the state of Rajasthan during the last three years is placed at Annexure-II.

(c): Comprehensive steps have been taken by the Government and the Reserve Bank of India (RBI) over the last few years to prevent and deter instances of bank frauds. These, *inter-alia*, include:

- (i) Banks to have robust internal audit and controls, early warning signals (EWS) and red flagging of accounts (RFA), timely reporting to agencies, data analytics and market intelligence unit for strengthening risk management systems;
- (ii) Prudential framework for resolution of stressed assets for early recognition and reporting;
- (iii) The Indian Cyber Crime Coordination Centre (I4C) has operationalised Citizen Financial Cyber Fraud Reporting and Management System (CFCFRMS) portal for immediate reporting of financial frauds to stop siphoning-off of funds by the fraudsters;
- (iv) Banks are required to have in place a board-approved policy on fraud risk management, delineating roles and responsibilities of Board / Board Committees and senior management. Banks are also required to set-up an appropriate organisational structure for institutionalisation of fraud risk management;
- (v) A senior official in the rank of at least a General Manager or equivalent is responsible for monitoring and reporting of frauds; and
- (vi) Banks are required to furnish fraud monitoring return (FMR) to RBI in individual fraud cases, irrespective of the amount involved, immediately, not later than fourteen days from the date of classification of an incident / account as fraud.

The details of complaints received and frauds in respect of loans given by banks is not maintained centrally.
