(a): The details of statutory targets and expenditure of Corporate Social Responsibility (CSR) of Public Sector Undertakings under Ministry of Coal over the last five financial years are given at **Annexure A**.

(b) & (c): As per the provisions of the Companies Act, 2013, CSR is a Board driven process and the Board of the CSR mandated company is empowered to plan, decide, execute and monitor CSR activities undertaken in the areas or subjects specified in Schedule VII of the Act, based on the recommendation of its CSR Committee. The key thrust areas for CSR inter alia include Healthcare, Sanitation & Nutrition, Promoting Education, Skilling & Livelihood, Rural Development, Environmental Sustainability, Promotion of Sports, etc. Details of area-wise CSR expenditure of the Public Sector Undertakings under Ministry of Coal during last five financial years are given at **Annexure B**.
