STATUS OF PUBLIC BUS TRANSPORT INFRASTRUCTURE IN DELHI

2769. MS. SWATI MALIWAL:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the estimated requirement and current availability of public buses in the National Capital Territory of Delhi to meet urban transportation demand;
- (b) number of new buses inducted into the public transport fleet during the last five years, including type (CNG/electric), and details of Central and/or State Government funds allocated, released, and utilised year-wise;
- age profile of the existing bus fleet, specifying number of buses in each age category (0–5 years, 5–10 years, over 10 years); and
- (d) whether there is a roadmap to phase out older CNG buses and fully transition to electric buses, with targets and timelines?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI TOKHAN SAHU)

- (a) The Government of NCT of Delhi has reported that the ratio of buses to be provided by Delhi Transport Corporation (DTC) and Private Clusters should be 50:50 of 11,000 buses. Current availability of buses under Department of Transport, Govt. of NCT of Delhi is 5691 i.e. 3203 DTC Buses & 2488 Cluster Buses.
- (b) Year-wise details of the number of new buses inducted under Department of Transport, Govt of NCT of Delhi during last 05 Years is provided in **Annexure-I.**

Further, all cluster buses are being inducted on Gross Cost Contract (GCC) model by Department of Transport, Govt of NCT of Delhi. During the last five years no funds have been released by Central/ or State Government to DTC for purchase of new CNG Buses. However, the details of subsidy received by DTC from Government of NCT of Delhi and Government of India for Electric Buses are given in **Annexure II.**

(c) The details of the age profile of existing bus fleet is given as under: -
