- (a) the objectives and scope of the Udyam Sakhi portal, including the details of support services available to women entrepreneurs;
- (b) the number of women who have been registered and benefitted through the portal, details thereof including the State of Jharkhand;
- (c) the expenditure incurred in developing and maintaining the portal; and
- (d) the steps taken to enhance the portal's effectiveness and outreach in backward districts?

(a): The Udyam Sakhi Portal i.e. <https://udyamsakhi.com/> is designed to support women entrepreneurs and provides information about various financial schemes, policies, programmes & supporting institutions functioning under the administrative control of the Ministry of Micro, Small & Medium Enterprises (MSME). This portal helps women entrepreneurs to start, build and grow their businesses and become self-reliant.

It provides the information relating to (i) Financial Schemes of the Ministry of MSME such as PMEGP; CGTMSE; MUDRA; TReDS etc. (ii) Policies and Programmes of the Ministry of MSME & other Central Ministries. (iii) Information about preparation of Business plan. (iv) Details of Nodal offices / supporting organisations of the Ministry of MSME in the respective States in the Country. (v) Information about exhibitions, trade fairs & international events organised by the Ministry of MSME.

(b) to (d): A total of 4535 women have so far registered on the portal, out of which 34 women belong to the State of Jharkhand. An expenditure of Rs. 43.52 lakhs was incurred for development of the Udyam Sakhi portal in the year 2018.
