**INCIDENTS OF VIOLENCE AGAINST MINORITY COMMUNITIES**

2827. DR. JOHN BRITTAS:  
SHRI A. A. RAHIM:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) total number of reported incidents of violence against minority communities in the country since 2020, year-wise and State-wise details thereof;
- (b) whether Government has identified any specific reasons or trends behind the reported rise in incidents of violence targeting minorities communities; and
- (c) the measures taken or proposed by the Central Government for States Government to prevent such incidents and ensure the safety and security of minority communities, details thereof?

**ANSWER**

(a) to (c): 'Public Order' and 'Police' are subjects under the State list in the seventh schedule of the Constitution of India. As such, the respective State Governments are responsible for prevention, detection and investigation of such crimes and for prosecuting criminals through the law.

The petitions received in the National Commission for Minorities (NCM), Ministry of Minority Affairs are taken up with the concerned authorities/State Governments for necessary action. The State-wise and year-wise details of number of Petitions, as received in the Commission, during the last five years and current year, are annexed.
