**“Prevention of spurious Ayush medicines and products”**

**2881 # Shri Neeraj Dangi:**

Will the Minister of Ayush be pleased to state:

- (a) whether Government is aware of the incidents of manufacture and sale of spurious Ayush medicines in the country, if so, the details thereof, State-wise;
- (b) the details of licenses of companies manufacturing spurious Ayush medicines cancelled by Government in the last two years and the amount seized from them;
- (c) the details of Government's active agencies to take action against spurious Ayush and other adulterated medicines; and
- (d) the steps being taken by Government to prevent spurious Ayush medicines?

**ANSWER**

**THE MINISTER OF STATE (IC) OF THE MINISTRY OF AYUSH  
(SHRI PRATAPRAO JADHAV)**

(a) to (d) The Drugs & Cosmetics Act, 1940 and Drugs Rules, 1945, have exclusive regulatory provisions for Ayurvedic, Siddha, Unani, Sowa-Rigpa and Homoeopathy drugs. Provisions related to spurious Ayurveda, Siddha and Unani drugs are prescribed under the Section 33EEA and penalty for manufacture for sale or for distribution of any such drugs are prescribed under the section 33I of Drugs and Cosmetics Act, 1940. Further, Rule 159 of Drugs Rules, 1945 have provisions for cancellation or suspension of licences if the licensee has failed to comply with any

of the conditions of the licence or with any provisions of the Drugs and Cosmetics Act, 1940 or the Rules made thereunder.

As per the information received from states/UTs Governments, the details of companies whose licenses have been cancelled for manufacturing spurious Ayush medicines in the last two years are attached at **Annexure-I**.

As prescribed in Drugs and Cosmetics Act, 1940 and Drugs Rules, 1945, enforcement of the legal provisions pertaining to Quality Control and issuance of drug license of Ayurveda, Siddha and Unani drugs, is vested with the State Drug Controllers/State Licensing Authorities appointed by the concerned State/ Union Territory Government.

Drug Inspectors collect medicine samples regularly from manufacturing firms or sale shops within their jurisdiction and send them to Drug Testing Laboratories, recognized under Rule 160 A to J of the Drugs Rules, 1945 (34 State/UTs Drug Testing Laboratories & 108 private Drug Testing Laboratories) for quality testing and if any sample is found to be 'Not of Standard Quality', appropriate action is initiated such as preventing the sale of the medicines from the market and appropriate legal actions as per Drugs and Cosmetics Act, 1940 and Rules made thereunder.

Pharmacopoeia Commission for Indian Medicine & Homoeopathy (PCIM&H), subordinate office under Ministry of Ayush lays down the formulary specifications and pharmacopoeial standards for Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) drugs which serves as official compendia for ascertaining the quality (identity, purity and strength) of the ASU&H drugs. PCIM&H also acts as the Central Drugs Laboratory for Indian Medicine and Homoeopathy for the purpose of testing or analysis of ASU&H Drugs.

Ministry of Ayush has implemented Central Sector Scheme Ayush Oushadhi Gunvatta Evam Utpadan Samvardhan Yojana (AOGUSY) to support Ayush Pharmacies and Drug Testing Laboratories to achieve higher standards under one of the components. The total financial allocation to this scheme is Rs. 122.00 crores for five years.

Further Ministry of Ayush encourages following certifications of Ayush products as per details below:-

- An Ayush vertical has been created in Central Drugs Standard Control Organization (CDSCO) to strengthen regulatory measures ensuring safety and quality of Ayush drugs. Further, CDSCO issues WHO Certificate of Pharmaceutical Product (WHO-CoPP) to Ayush drugs having compliance to such standards.
- Quality Council of India (QCI) has implemented Quality Certifications Scheme for grant of Ayush standard and premium marks to Ayurvedic, Siddha and Unani medicine based on third-party evaluation of quality in accordance with the status of compliance to domestic and international standards.
