Resolution of Gas Pricing Dispute

Will the Minister of **CHEMICALS AND FERTILIZERS** be pleased to state:

- (a) the details of the total claims lodged by domestic urea producers over revised gas marketing margins along with year-wise amounts and how much has been settled to date between March 2022 - 2025.
- (b) the details of the urea manufacturers provided financial settlements to resolve previous gas cost disputes; and
- (c) the details of mechanisms established to resolve pending legacy claims and prevent future disputes which may affect fertilizer pricing?
