Will the Minister of *Finance* be pleased to state:

- (a) the list of new PSUs that were started within the last five years in the country, State-wise;
- (b) the list of PSUs that have been privatised in the last five years in the country, State-wise;
- (c) the list of PSUs that are making profits, State-wise;
- (d) whether Government is planning to disinvest more PSUs; and
- (e) if so, the details thereof?

**ANSWER**

**THE MINISTER OF STATE FOR FINANCE

(a): Central Public Sector Enterprises (CPSEs) function under the administrative control of respective Ministries/Departments. Any decision to set up new CPSEs is taken by the sectoral line Ministries/Departments after taking into consideration the needs, commercial viability and any extant policy of the Government. As per the Public Enterprises (PE) Survey 2023-24, the list of Central Public Sector Enterprises (CPSEs) incorporated during the years 2019 to 2024 along with States/UTs where their registered office is located is at Annexure-I. Most CPSEs have operations beyond the place of their incorporation.

(b): As per Department of Investment and Public Asset Management (DIPAM), the following CPSEs were strategically disinvested during the last five years.

(c): As per the PE Survey 2023-24, the list of profit making CPSEs for the Financial Year 2023-24 alongwith States/UTs where their registered office is located is at Annexure- II.

(d) & (e): Government carries out disinvestment through (i) Minority Stake Sale and (ii) Strategic Disinvestment of CPSEs. Minority stake sale in CPSEs without transfer of management control is implemented through various SEBI-approved methods such as Initial Public Offer (IPO), Offer for Sale (OFS), Buyback of shares etc., in order to unlock the value, promote public ownership, meet the minimum public shareholding norms of SEBI and for ensuring higher degree of accountability. Strategic Disinvestment implies entire or substantial sale of Government shareholding of a CPSE along with transfer of management control.
