**SUDDEN INCREASE IN CORONA CASES**

Will the Minister of **HEALTH & FAMILY WELFARE** be pleased to state:

- (a) whether WHO issued warning of corona as there was sudden increase in cases of the disease in several countries including India since the summer of 2025;
- (b) if so, the details thereof;
- (c) whether special variants like Nimbus and XFG are mainly responsible for the new wave of corona; and
- (d) if so, the details of plan of action proposed by Government, including issuing advisories to the State Governments?

**(a) to (c)** The World Health Organization (WHO) on 28 May 2025, issued a Disease Outbreak News (DON) wherein it highlighted that since mid-February 2025, global SARS-CoV-2 activity has been increasing, particularly from countries in the Eastern Mediterranean, South-East Asia, and Western Pacific regions, including India. The said report also pointed out that while since early 2025, global SARS-CoV-2 variant trends have slightly shifted and reporting of NB.1.8.1 variant (Nimbus) is increasing, the overall increases in COVID-19 are broadly consistent with levels observed during the same period in the previous year.

As per WHO risk assessment, the available evidence on NB.1.8.1 and XFG does not suggest additional public health risks relative to the other currently circulating Omicron descendent lineages.

**(d)** By the end of May, 2025, a surge in COVID-19 trajectory of cases was also witnessed in the country, which peaked around 13 June 2025. Since then, the trajectory of COVID-19 cases in the

country has declined significantly. As reported by States/UTs, most of the cases were mild in nature and resolved on their own.

Ministry of Health and Family Welfare on 29 May 2025 issued an advisory to all States/UTs to undertake review of hospital preparedness with special focus on the availability of diagnostics, essential drugs, PPEs, isolation beds, medical oxygen, ICU and ventilator supported beds.

All States/UTs were also requested to closely follow the trend of Influenza Like Illness/ Severe Acute Respiratory Illness while undertaking testing for COVID-19 as per this Ministry's 'Operational Guidelines for Revised Surveillance Strategy in context of COVID-19'. State/UTs were also advised to refer adequate number of samples for whole genomic sequencing.

The Ministry also urged all States/UTs to undertake mock drills to assess preparedness and operational readiness of all health facilities in the country including requisite infrastructure, logistics (including drugs and equipment) as well as healthcare workforce in the country.

With the long-term goal to better prepare our country against public health emergencies, Pradhan Mantri - Ayushman Bharat Health Infrastructure Mission (PM-ABHIM) has been launched with the intent to enhance the capacity of primary, secondary and tertiary health care facilities/systems and institutes for identifying and managing any new and emerging diseases.
