- (a) the number and value of MoUs signed in the renewable energy sector for Rajasthan, Gujarat & North Eastern Region and their impact on employment and growth;
- (b) the percentage of the Ministries annual plan funds earmarked for Rajasthan, Gujarat and NER and the quantum of central financial assistance increased for this sector under the Pradhan Mantri Surya Ghar: Muft Bijli Yojna and PM-KUSUM Yojana;
- (c) the details of renewable energy projects recently commissioned or under development in Rajasthan, Gujarat and NER; and
- (d) the number of individuals trained in this sector under Surya Mitra, Varun Mitra and Jal Urja Mitra Programmes?

- (a) The list of MoUs signed by Ministry of New and Renewable Energy in the renewable energy sector with Rajasthan, Gujarat & North Eastern Region and their estimated impact on employment and growth are placed as **Annexure I**.
- (b) There is no separate percentage of earmarking of funds for Rajasthan and Gujarat. However, for North Eastern Region 10% funds of the Ministry of New and Renewable Energy are earmarked with BE of Rs. 2626.00 crore for Financial Year 2025-26. The quantum of central financial assistance released for this sector under the Pradhan Mantri Surya Ghar: Muft Bijli Yojna and PM-KUSUM Yojana is placed as **Annexure II**.
- (c) The list of renewable energy projects commissioned in Rajasthan, Gujarat and NER is attached as **Annexure III**.
- (d) 63713 numbers of individual under Surya Mitra, 1276 numbers of individual under Varun Mitra and 601 numbers of individual under Jal Urja Mitra Programmes have been trained as on 30.06.2025 . The details of individual trained for Rajasthan, Gujarat and NER are placed as **Annexure IV**.
