Central funds allocated in the North Eastern States

3239. Shri Dorjee Tshering Lepcha:

Will the Minister of DEVELOPMENT OF NORTH EASTERN REGION be pleased to state:

- (a) whether the works are being carried out under the Non-Lapsable Central Pool of Resources (NLCPR), North East Special Infrastructure Development Schemes (NESIDS) and Hill Area Development Programme (HADP) in the North Eastern States, particularly in Sikkim;
- (b) if so, the details and current status, scheme-wise thereof; and
- (c) the details of the central funds allocated and utilized during the last five years including current year, State-wise?

(a)& (b) The North East Special Infrastructure Development Scheme (NESIDS) was approved as a new Central Sector Scheme in 2017-18 and restructured into two components viz. NESIDS (Roads) and NESIDS (Other Than Roads Infrastructure) in 2022-23. The NESIDS (OTRI) component subsumed the committed liabilities of the ongoing projects, as on 01.04.2022, sanctioned under the schemes of Non-Lapsable Central Pool of Resources (NLCPR), North East Special Infrastructure Development Scheme (NESIDS) and Hill Area Development Programme (HADP). The Hill Area Development Programme (HADP) was launched by the Ministry of Development of North Eastern Region (MDoNER) on pilot basis for 2 years i.e. 2018-19 and 2019-20 in Tamenglong (now Tamenglong and Noney) district of Manipur. The State-wise

details of projects sanctioned under the schemes of NLCPR, NESIDS and HADP is at **Annexure- I.**

(c) The details of the funds released by the Ministry of Development of North Eastern Region against the projects sanctioned under the Schemes of NLCPR, NESIDS, HADP and NESIDS(OTRI) during the last five years and in the current year upto 31.07.2025, is at **Annexure- II.**
