FDI RECEIVED BY STATES

686. DR. BHIM SINGH:

Will the Minister of **Commerce and Industry** be pleased to state:

- (a) the total amount of Foreign Direct Investment (FDI) received by the States in the last five years and the FDI received so far in the current financial year 2024–25, State-wise, particularly the year-wise data of FDI received by Bihar; and
- (b) the total public investment through public sector undertakings or Public-Private Partnership (PPP) projects during this period, State-wise and the details of the sector-wise distribution of these projects—such as infrastructure, energy, manufacturing, etc.?

- (a): The total Foreign Direct Investment (FDI) inflow includes equity inflow, equity capital of unincorporated bodies, re-invested earnings, and other capital. The State-wise details for FDI equity inflow are maintained since October, 2019. Accordingly, the state-wise and financial year-wise details of FDI equity inflow reported in the country since October, 2019 till March 2025, including Bihar, are at Annexure-I.
- (b): The State-wise and sector wise details of ongoing central sector projects costing ₹ 150 crore and above as on 22.07.2025, as per data of Ministry of Statistics and Programme Implementation (MoSPI) are at Annexure - II. Further, the data relating to project investment through Public-Private Partnership (PPP) is not captured centrally.
