PLANS TO SELECT AND APPROVE NEW SMART CITY PROJECTS UNDER THE SCM

867. DR. M. THAMBIDURAI:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether there are any plans to select and approve new smart city projects under the Smart Cities Mission (SCM);
- (b) if so, the details thereof;
- (c) whether the drinking water and sanitation infrastructure are aimed to be improved after the implementation of the said projects;
- (d) if so, the details thereof;
- (e) whether there is any funding for waste management and recycling projects; and
- (f) if so, the details thereof, State-wise during the last five years, including this year?

- (a) & (b): With the closure of Smart Cities Mission (SCM) on March 31, 2025, there is no further budgetary provision under SCM.
- (c) to (f): Under SCM, 1,545 projects amounting to ₹49,621 crore have been undertaken by the smart cities in the Water Sanitation and Hygiene (WASH) sector. The projects, *inter-alia*, include development of infrastructure of water supply and sanitation, Sewage Treatment Plants, Water Treatment Plants, automation through Supervisory Control and Data Acquisition (SCADA), Solid Waste Recycling Plants, Transfer Stations, etc. State/UT wise list of projects undertaken in SCM under WASH sector is at Annexure.
