IMPLEMENTATION STATUS OF UDYAM SAKHI PORTAL

*158. SMT. RAJATHI:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the list of States/UTs in which the Udyam Sakhi Portal has been implemented and is currently operational;
- (b) the number of women entrepreneurs registered from each State/UT;
- (c) the services offered to women under the Udyam Sakhi Portal; and
- (d) the reasons for low conversion rate from registration and awareness to actual enterprise creation or handholding support under the Udyam Sakhi platform?

STATEMENT REFERRED TO IN REPLY TO RAJYA SABHA STARRED QUESTION NO. *158 FOR 15.12.2025 REGARDING IMPLEMENTATION STATUS OF UDYAM SAKHI PORTAL.

(a) to (d): The details of State/UTs, wherein women entrepreneurs have registered and benefited under the centrally maintained Udyam Sakhi Portal, since its inception in 2018, are given at **Annexure-I**.

Udyam Sakhi Portal provides information regarding financial schemes, policies and programmes of the Ministry of Micro, Small and Medium Enterprises (MSME) to existing and prospective women entrepreneurs in the MSME sector.

In fact, to facilitate ease of doing business and registration of MSMEs and accelerate the formalization of enterprises, including the women enterprises, in the country, Udyam Registration Portal (URP) was launched by the Government on 01.07.2020. The process of registration on Udyam Portal is simple, paperless, free, digital and based on self-declaration. For those Informal Micro Enterprises (IMEs), which are exempted from GST, Udyam Assist Platform (UAP) was launched on 11.01.2023 in association with Small Industries Development Bank of India (SIDBI). Since inception of Udyam, so far 7,22,32,260 MSMEs have been digitally registered on Udyam, out of which 2,86,39,991 enterprises are owned by women which is 39%.

Further, to empower women entrepreneurs, the Ministry of MSME launched the 'Yashasvini Campaign' on 27.06.2024. The objective of this initiative is to empower women entrepreneurs across the country, through various schemes, on formalization, access to credit capacity building and mentorship through awareness generation about these schemes.

Ministry of MSME, through its country-wide field offices, i.e., Development and Facilitation Offices (DFOs), and in coordination with State Governments, MSME Associations and other stakeholders, promotes formalisation/ registration drives and handholding for enterprises especially women owned enterprises.
