STATEMENT REFERRED TO IN REPLY TO PARTS (a) AND (b) OF RAJYA SABHA STARRED QUESTION NO. 171 FOR ANSWER ON 16th DECEMBER, 2025 REGARDING 'REVISED PROCUREMENT TARGETS FOR PADDY AND RICE'

(a): The State-wise revised paddy procurement estimates fixed by Government of India (GoI) for Central Pool during KMS 2024-25 (cumulative of Kharif and Rabi crops) are placed at **Annexure**.

(b): There are no curbs imposed by the Government of India on procurement of paddy by the State Governments. The estimates for procurement of paddy are finalized by the GoI after consultations with the respective State Governments, before the commencement of each marketing season, taking into account a range of factors including estimated production, past years' procurement, and marketable surplus.
