MONUMENTS BY PRIVATE PLAYERS**

- (a) The Adopt A Heritage 2.0 program, launched in September 2023, provides a & framework for engagement with private and public sector entities, as well as
- (b) NGOs, trusts, and societies, for the development and maintenance of visitor amenities at protected monuments. The involvement of stakeholders is strictly limited to non-conservation activities, including cleaning of premises and provision as well as upkeep of amenities such as washrooms, drinking water, child-care rooms, benches, pathways, garbage bins, signage, sound-and-light shows, and illumination. All works for provision of amenities are undertaken in close consultation and guidance of the Archaeological Survey of India (ASI).
- (c) Under National Culture Fund, Conservation activities are funded by public and Private donors and the conservation works are executed under the supervision of ASI.
- (d) As of date, the total accumulated corpus of the National Culture Fund (NCF) is ₹50.04 Crores.
