(a) to (d): Funds are released Scheme-wise and not State-wise or component-wise in this Ministry. Details of funds released under Khelo India Scheme across the country, including in the State of Punjab, including for sports infrastructure and development projects during the last three years and the current year are as under:

2025-26 (as on 28.11.2025)	599.12
