CSR ALLOCATIONS BY COMPANIES

QUESTION

1017. DR. V. SIVADASAN:

Will the Minister of Corporate Affairs be pleased to state:

- (a) the year-wise and sector-wise total CSR expenditure made by companies across the country since 2015-16 and place the details on the Table;
- (b) whether any educational or health institutions receiving CSR funds also collect money from people for the same services and if so, the names of such institutions; and
- (c) whether any company has given CSR funds to an institution in which it or its related parties hold shares, partnership, or other financial interest and if so, the names of such companies and institutions along with the details?

(a): On the basis of annual filings made by companies in the MCA21 registry, the development sector-wise CSR expenditure in India from FY 2015-16 to FY 2023-24 is attached at Annexure.

(b): Such information is not required to be maintained under the provisions of the Companies Act..

(c): Under Section 135 of the Companies Act, 2013 read with Rule 4(1) of the Companies (CSR Policy) Rules, 2014, it is prescribed that the Board of the company is empowered to undertake its CSR activities either by itself or through-

- i. a company established under section 8 of the Act, or a registered public trust or a registered society, exempted under sub-clauses (iv), (v), (vi) or (via) of clause (23C) of section 10 or registered under section 12A and approved under 80 G of the Income Tax Act, 1961 (43 of 1961), established by the company, either singly or along with any other company; or
- ii. a company established under section 8 of the Act or a registered trust or a registered society, established by the Central Government or State Government; or
- iii. any entity established under an Act of Parliament or a State legislature; or
- iv. a company established under section 8 of the Act, or a registered public trust or a registered society, exempted under sub-clauses (iv), (v), (vi) or (via) of clause (23C) of section 10 or registered under section 12A and approved under 80 G of the Income Tax Act, 1961, and having an established track record of at least three years in undertaking similar activities.

CSR specific list of related parties is not separately kept. However, companies are required to disclose the details of such institutions as per the applicable accounting standards pertaining to related party disclosures, in the financial statement.
