ENROLLMENT UNDER PM VISHWAKARMA YOJANA

113. DR. KALPANA SAINI:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of artisans who applied for PM-Vishwakarma Yojana and the number of those artisans who got enrolled therein, State-wise details thereof;
- (b) the number of cases where the process of verification and approval has been completed, so far, under the scheme; and
- (c) current stage of distribution of benefits and facilities to the enrolled artisans, the details thereof?

ANSWER

- (a): PM Vishwakarma scheme was launched on 17.09.2023, for a period of five years (FY 2023-24 to 2027-28) to provide end-to-end holistic support to artisans and craftspeople of 18 traditional trades who work with their hands and tools. The State-wise number of artisans who have been enrolled under PM Vishwakarma scheme is at **Annexure –I**.
- (b): Against the target of coverage of 30 lakh beneficiaries, the process of verification and registration of 30 lakh artisans/craftspeople has been successfully completed under the scheme.
- (c): Out of 30 lakh registered PM Vishwakarma beneficiaries; all 30 lakh beneficiaries have been provided with PMV Certificates and ID cards, 23.08 lakh beneficiaries have been provided Skill Training, 6.83 lakh beneficiaries have been paid digital incentive amounting to Rs. 23.33 crore, 5.17 lakh beneficiaries have been provided with collateral free Enterprise Development Loans at a concessional rate of 5% amounting to Rs. 4458 crore and modern toolkits have been delivered to 10.41 lakh beneficiaries at their doorstep through India Post. Also, all the PM Vishwakarma beneficiaries are registered on the Udyam Assist Platform (UAP) of Ministry of MSME, making them eligible for various government schemes such as Credit Guarantee scheme and also considered for priority sector lending.
