#### REVIVAL OF SMALL-SCALE AND MSME CLUSTERS IN EASTERN INDIA

### 114. SHRI AKHILESH PRASAD SINGH:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) number of Micro, Small and Medium Enterprises (MSME) clusters approved and made operational in Bihar under the SFURTI and Cluster Development Programme;
- (b) whether Government proposes any fiscal package or credit-guarantee support for closed industrial units in the Patna-Gaya region; and
- (c) steps taken to strengthen marketing, export facilitation, and digital onboarding of MSMEs from eastern States?

#### **ANSWER**

# MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a): 10 clusters approved, out of which 08 are operational under Scheme of Fund for Regeneration of Traditional Industries (SFURTI) and 01 project of Common Facility Center (CFC) have been approved and operational under Micro and Small Enterprises Cluster Development Programme (MSE-CDP) in State of Bihar.
- (b): Ministry of Micro, Small and Medium Enterprises implements the Credit Guarantee Scheme (CGS) for Micro and Small Enterprises (MSEs) through Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) to provide credit guarantee for loans upto Rs. 10 crore extended by Member Lending Institutions to new as well as existing MSEs without collateral security and third-party guarantee across the country including those in Bihar. The data for credit guarantees extended to MSEs under CGS in Bihar is as below:
