**UPGRADATION OF INDUSTRIAL TRAINING INSTITUTES (ITIs)**

1241. SHRI RATANJIT PRATAP NARAIN SINGH:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the national status of the Skill India Mission in upgrading Industrial Training Institutes (ITIs);
- (b) the number of ITIs in the State of Uttar Pradesh that have been modernized or partnered with industry leaders (like Tata);
- (c) the status of Government and private ITIs in Kushinagar district, including their infrastructure and instructor vacancies;
- (d) the status of any proposal to upgrade Government ITI with new trades related to electronics, solar energy or MRO (aviation); and
- (e) the steps to improve industry apprenticeships for ITI graduates from Kushinagar?

**ANSWER**

THE MINISTER OF STATE (INDEPENDENT CHARGE) IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI JAYANT CHAUDHARY)

- (a) The Cabinet has approved the Pradhan Mantri Skilling and Employability through Upgraded ITIs (PM SETU) scheme to enhance the overall quality and relevance of vocational training in the country. The scheme comprises of two components:
- i. Component I – Upgradation of 1,000 Government ITIs (200 Hub ITIs and 800 Spoke ITIs) in a Hub and Spoke model. These ITIs are proposed to be upgraded with smart classrooms, modern labs, digital content, and new courses aligned to industry needs.
  - ii. Component II – Capacity Augmentation of five National Skill Training Institutes (NSTIs) located in Bhubaneswar, Chennai, Hyderabad, Kanpur, and Ludhiana, including setting-up sector-specific National Centres of Excellence for skilling, with focus on advanced training of trainers with global partnership.

The total estimated outlay of the scheme is ₹60,000 crore, with contributions from the Central Government (₹30,000 crore), State Governments (₹20,000 crore), and Industry Partners (₹10,000 crore) over a five-year period.

The guidelines for roll-out of scheme are issued after approval of National Steering Committee under PM-SETU scheme. As per the guidelines, States/UT are required to form the State Steering Committee and float Expression of Interest/ Request for proposal for receiving proposals from Industry Partners. As on date, as per the communication received 11 States/UTs (Andhra Pradesh, Assam, Chandigarh, Delhi, Karnataka, Ladakh, Madhya Pradesh, Meghalaya, Sikkim, Telangana, Uttar Pradesh) have notified their State Steering Committee. However, no industry proposal has been forwarded by SSC for approval of National Steering Committee.

- (b) The State Government of Uttar Pradesh has undertaken the modernization of 127 NCVT affiliated Government Industrial Training Institutes (ITIs) in collaboration with Tata Technologies. Under this

initiative, 7 NCVET-approved long-term Craftsmen Training Scheme (CTS) trades have been introduced in these ITIs. The list of ITIs is placed at *Annexure-I*. The details of the courses are as follows:

1. Mechanic Electric Vehicle
2. Manufacturing process Control and Automation
3. Advanced CNC Machining Technician
4. Industrial Robotics and Digital Manufacturing Technician
5. Basics Designer and Virtual Verifier (Mechanical)
6. CAM Programmer
7. Additive Manufacturing Technician (3D Printing)

(c) In the district of Kushinagar, Uttar Pradesh, a total of 29 ITIs are functioning, comprising 6 Government ITIs and 23 Private ITIs. These ITIs are operational under the Craftsmen Training Scheme (CTS) and are providing vocational training across various trades. The day-to-day administration and financial control of Government ITIs, including recruitment of instructors and maintenance of infrastructure, fall under the jurisdiction of the respective State Governments and UT Administrations.

As per the information available, the details of instructors in the ITIs of Kushinagar district are as below:

- i. Government ITIs: Out of 172 sanctioned instructor posts, 73 are filled and 99 are vacant.
- ii. Private ITIs: Out of 203 sanctioned instructor posts, 177 are filled and 26 are vacant.

The details regarding number of trades and enrolment are placed at *Annexure-II*.

(d) Under the PM-SETU scheme no proposal has been received from the state governments to upgrade Government ITI with new trades related to electronics, solar energy or MRO (aviation). However, DGT has introduced 31 new age courses under CTS including new trades related to electronics and solar energy. List of these new age courses and number of ITIs and NSTIs running these courses are given in *Annexure III*.

(e) The Government of India is proactively expanding opportunities for ITI graduates of Kushinagar through a series of targeted interventions under the National Apprenticeship Promotion Scheme (NAPS). By continuing NAPS in its second phase, the Government is ensuring that youth from districts like Kushinagar receive direct financial and career-building support. Under NAPS-2, the Government contributes 25% of the minimum prescribed stipend, up to ₹1,500 per month- directly into apprentices' bank accounts through the DBT system, ensuring transparency and timely support.

To make apprenticeship opportunities easily accessible for ITI graduates, the Government has operationalized a national digital platform that enables youth from Kushinagar to register online, create profiles, and apply for apprenticeship openings across the country. With more than 260 designated trades and over 750 optional trades available, the Government is expanding the scope of skill-based employment for local ITI graduates.

Acting on the decisions of the 38th Central Apprenticeship Council, the Government has also approved an enhanced minimum stipend for ITI apprentices, raising it from ₹7,000 to ₹9,600 from 11 September 2025. Additionally, ITI graduates undergoing apprenticeship have been exempted from the theory examination, reducing their administrative burden. On successful completion, their apprenticeship period is treated as valid work experience, enabling them to pursue better employment opportunities nationwide.

Through these proactive measures, the Government is ensuring that ITI graduates including those from Kushinagar receive greater financial support, wider access to opportunities, and a smoother transition into the workforce.
