“TAKE-HOME RATION BENEFICIARIES”

1266. SMT. PHULO DEVI NETAM:

Will the Minister of Women and Child Development be pleased to state:

- (a) the State-wise/UT-wise number and percentage of eligible Take Home Ration (THR) beneficiaries whose Face Recognition System (FRS) is still pending, as on date;
- (b) out of these, the State-wise/UT-wise number and percentage of beneficiaries whose FRS pendency is due to non-completion of e-KYC through OTP via Aadhaar linked mobile number;
- (c) the State-wise/UT-wise number and percentage of beneficiaries whose THR distribution has been kept on hold or paused due to repeated FRS failure; and
- (d) whether the Ministry has conducted any independent audit of the accuracy, error rates, demographic bias and offline-mode reliability of the FRS algorithm, and if so, the details thereof?

ANSWER

(a) to (c): State-wise/UT-wise details of implementation of Facial Recognition System (FRS) is placed at **Annexure I**.

Saksham Anganwadi and Mission Poshan 2.0 is a universal self-selecting umbrella scheme open to all eligible beneficiaries, i.e., Children under 6 years of age, pregnant women, lactating mothers till 6 months after childbirth and adolescent girls (14-18 years) in Northeastern States and Aspirational Districts of the country. Every beneficiary who is willing to undergo the e-KYC procedure and FRS is fully entitled to receive the benefits of the Scheme.

(d): In order to ensure that the benefits reach the actual/intended beneficiary and to remove duplication and risk of leakage of benefits and to make the scheme more transparent, the Ministry has introduced Face Recognition System (FRS) in August 2024 as a pilot in 6 States/UTs, viz., Andhra Pradesh, Gujarat, Haryana, Odisha, Uttar Pradesh and Chandigarh. Further, FRS was rolled out on Pan India basis in December 2024 with an option to distribute THR without FRS authentication. The entire process of onboarding beneficiaries for FRS is being taken up in a gradual manner.
