FINANCIAL ASSISTANCE AND TECHNICAL GUIDANCE TO PRIVATE COMPANIES, STARTUP AND COOPERATIVES IN FOOD PROCESSING SECTOR

1519. DR. VIKRAMJIT SINGH SAHNEY:

Will the Minister of ***FOOD PROCESSING INDUSTRIES*** be pleased to state:

- (a) whether Government is providing financial assistance and technical guidance to private companies, startups and cooperatives involved in the food processing sector in Punjab through Mega Food Park, Pradhan Mantri Formalization of Micro Food Processing Enterprises (PMFME) scheme or other means;
- (b) if so, the district-wise and scheme-wise details of the beneficiaries and assistance provided, along with the approved list of projects and grants distributed so far;
- (c) whether Government proposes to sanction additional Mega Food Park projects or Common Facility Centres in Punjab under the PMFME or other schemes; and
- (d) if so, timelines and criteria for such approvals, and if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI RAVNEET SINGH)

(a) & (b): In order to boost and ensure overall development of food processing sector, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of related infrastructure through its two Central Sector Schemes namely Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) and Production Linked Incentive Scheme for Food Processing Industry (PLISFPI). MoFPI is also implementing Centrally sponsored scheme namely PM Formalization of Micro Food Processing Enterprises (PMFME) scheme for providing financial, technical and business support for upgradation/ setting up of micro food processing enterprises.

All the three schemes are implemented across the country including Punjab. The Mega Food Park Scheme (MFP) is a component scheme of PMKSY and has been discontinued by MoFPI since 01.04.2021. MoFPI provides subsidy/incentives to the eligible applicants including private companies, startups and Cooperatives under these schemes. The details of food processing projects approved by MoFPI under the said three schemes in the State of Punjab is at **Annexure**.

(c) & (d): All the three schemes of MoFPI are not region specific but demand driven in nature and applications are invited online for sanctioning of projects, as per respective schemes guidelines. Under Support for Common Infrastructure component of PMFME, Credit linked capital subsidy @35% subject to maximum of Rs. 3 crore to support FPOs, SHGs, Cooperatives and any Government agency is available for setting up of common infrastructure. The common infrastructure shall be available for other units and public to utilize on hiring basis for substantial part of the capacity.

MoFPI is implementing a sub-component scheme under PMKSY namely Creation of Infrastructure for Agro Processing Clusters (APC), which is similar to the Mega Food Park scheme with a reduced requirement of 10 acres of land.
