## AIR PASSENGER TRAFFIC IN MAHARASHTRA

#### 1606. SHRI DHANANJAY BHIMRAO MAHADIK

Will the Minister of CIVIL AVIATION be pleased to state:-

- (a) the passenger traffic handled by Maharashtra airports during the last three years;
- (b) whether steps are being taken to enhance cargo and maintenance facilities in the State; and
- (c) if so, the details thereof?

#### **ANSWER**

## MINISTER OF STATE IN THE MINISTRY OF CIVIL AVIATION

- (a): The passenger traffic handled during the last three years by operational airports located in Maharashtra is at Annexure.
- (b) & (c): AAI Cargo Logistics and Allied Services Company Ltd. (AAICLAS) is facilitating air cargo movement from Pune, Aurangabad, Jalgaon and Kolhapur airports in the State of Maharashtra. Other airports in the State handling air cargo include Mumbai (MIAL), Nagpur (MIHAN), Nashik (HAL) and Shirdi (State Government).

At Pune and Aurangabad Airports, AAICLAS has established International and Domestic Air Cargo facilities with annual handling capacities of 6,500 MT (International) and 36,300 MT (Domestic) at Pune, and 16,400 MT (International) and 14,050 MT (Domestic) at Aurangabad. At Shirdi Airport, cargo movement is presently supported through belly cargo services. At Jalgaon and Kolhapur airports, domestic air cargo movement is facilitated through the respective domestic passenger terminals.

AI Engineering Services Limited (AIESL), the largest Maintenance, Repair and Overhaul (MRO) organisation in India, has been providing line maintenance

services to domestic and international airlines operating at various major airports of Maharashtra State. AIESL has base maintenance facilities at Mumbai and Nagpur airports.

Further, the Government has taken several measures for the development of MRO sector in the country which include issuance of new MRO guidelines on 01.09.2021, reduction of taxes (IGST) on imports of aircraft components and aircraft engine parts to 5%, extension of time-limit for re-import of goods for repairs under warranty etc.
