**STATUS OF PMAY-U IN KARNATAKA**

**1667. SHRI NARAYANA KORAGAPPA:**

**Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:**

- (a) whether the Central Government has sanctioned 2.75 lakh houses for the State of Karnataka under PMAY-U;
- (b) whether it is a fact that only 85,000 houses have been occupied and more than 40,000 houses have been completed but not handed over to the beneficiaries;
- (c) if so, the details thereof, district-wise; and
- (d) the efforts being made by the Central Government to handover completed houses to the beneficiaries?

**ANSWER**

(SHRI TOKHAN SAHU)**

(a) to (d): Ministry of Housing and Urban Affairs (MoHUA) has been implementing Pradhan Mantri Awas Yojana - Urban (PMAY-U) since 25.06.2015 to provide all weather pucca houses with basic civic amenities to eligible urban beneficiaries across the country. The scheme period, which was earlier up to 31.03.2022, has further been extended up to 31.12.2025 to complete sanctioned houses without changing the funding pattern and implementation methodology.

Based on the learnings from the experiences of implementation of PMAY-U, MoHUA has revamped the scheme and launched PMAY-U 2.0 'Housing for All' Mission with effect from 01.09.2024 for implementation in urban areas across the country to support 1 crore additional eligible beneficiaries in next five years. PMAY-U 2.0 is implemented through four verticals i.e., Beneficiary Led Construction (BLC), Affordable Housing in Partnership (AHP), Affordable Rental Housing (ARH) and Interest Subsidy Scheme (ISS).

Based on proposals received, a total of 5.77 lakh houses including 2.74 lakh AHP houses have been sanctioned under PMAY-U for the State of Karnataka. As per information provided by the State Government, of the sanctioned AHP houses, 2.05 lakh houses have been grounded for construction and 1.26 lakh houses have completed/delivered. District-wise details of AHP houses sanctioned, grounded for construction, completed and occupied in Karnataka are at Annexure.

The Ministry reviews the progress under PMAY-U regularly through Monthly Progress Reports (MPRs), Monthly Review Meetings and in the meetings of Central Sanctioning and Monitoring Committee (CSMC) so that all the sanctioned houses are completed and occupied within the stipulated timeframe.
