1701. MS. DOLA SEN:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the percentage of annual procurement by the Central Ministries and Public Sector Enterprises (PSEs) from MSMEs during the last five years, including procurement from women-led and SC/ST-led MSMEs, year-wise;
- (b) the Central Ministries and PSEs that did not achieve the mandated procurement targets and sub-targets during the last five years, with year-wise and Government/PSE-wise information; and
- (c) the number and total value (in ₹) of delayed payment cases relating to central ministries and PSEs, along with detailed particulars?
