**IMPLEMENTATION STATUS OF VARIOUS FUND SUPPORT SCHEMES**

1704: SHRI RYAGA KRISHNAIAH:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the latest status of implementation of the various fund support Schemes across States and Union Territories, including the number of States/UTs;
- (b) the total number of Micro Small and Medium Enterprises (MSMEs) benefitted under the Schemes to date, State/UT-wise;
- (c) the quantum of World Bank assistance reimbursed so far to Government under the result-based funding mechanism;
- (d) whether Government has undertaken any assessment of the impact of Schemes on improving MSME processes, market access, greening initiatives and support for women-owned enterprises; and
- (e) if so, the key findings thereof?

**ANSWER**

(a) & (b): The Government of India supplements the efforts of the States/UTs through various schemes, programmes and policy initiatives for promotion, development of MSMEs in the country. The Ministry of MSME implements Prime Minister's Employment Generation Programme, PM Vishwakarma scheme, Credit Guarantee Scheme for Micro and Small Enterprises, Raising and Accelerating MSME Performance (RAMP), Procurement and Marketing Support (PMS) scheme and Self-Reliant India Fund (SRI Fund). Status of implementation of these schemes across States and Union Territories implemented by the Ministry is as under:

- (i) Prime Minister's Employment Generation Programme (PMEGP) is a credit linked subsidy programme aimed at generating self-employment opportunities through establishment of micro-enterprises in the non-farm sector by helping traditional artisans and rural/urban unemployed youths through Margin Money subsidy. State/UT wise details are at Annexure – I.
- (ii) PM Vishwakarma Scheme provides end-to-end holistic support to artisans and craftspeople of 18 traditional trades who work with their hands and tools. It includes Skill Upgradation, Toolkit Incentive, Credit Support. State/UT wise details of beneficiaries assisted and loan applications sanctioned is at Annexure -II.

- (iii) Under Credit Guarantee Scheme (CGS) for Micro and Small Enterprises (MSEs), credit guarantee for loans extended to MSEs without collateral security and third-party guarantee through Credit Guarantee Fund Trust for MSEs (CGTMSE). State/UT wise details of guarantees approved is at Annexure-III.
- (iv) Self-Reliant India Fund has been set up to infuse Rs. 50,000 crore as equity funding in Micro, Small and Medium Enterprises with a provision of Rs. 10,000 crore from the Government of India and Rs. 40,000 crore through Private Equity/Venture Capital Funds. State/UT wise details of MSMEs benefitted under SRI Fund are at Annexure-IV.
- (v) The Scheme of Raising and Accelerating MSME Performance aims at strengthening Institutions and governance at the Centre and State-level, improving Centre-State linkages and partnerships, improving access to market and credit, addressing issues of delayed payments and greening of MSMEs and promoting guarantees to women entrepreneurs. Under the scheme, Strategic Investment Plans are made which include plan for identification of key constraints and gaps, set milestones and project the required budgets for interventions in priority sectors. Based on the Strategic Investment Plans (SIPs) submitted by 36 States / UTs, Ministry has approved projects worth Rs. 3031.77 Cr for gap funding. State/UT wise MSMEs benefitted is at Annexure-V.
- (vi) Procurement and Marketing Support (PMS) scheme extends benefits for creating market access initiatives to Micro & Small Enterprises in strengthening their market presence, enhancing product visibility, and improving access to domestic markets.
