CREDIT GAP FOR MSMEs IN THE COUNTRY

1709. SHRI RAGHAV CHADHA:

Will the Minister of Micro, Small and Medium Enterprises be pleased to state:

- (a) whether Government is aware of the increasing credit gap available to MSMEs in the country and if so, the reasons therefor;
- (b) whether any measures have been taken by Government on a policy level to cater to the issue and if so, the details thereof; and
- (c) details on the credit support provided to MSMEs by Government during the last five years, year-wise and State-wise?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SUSHRI SHOBHA KARANDLAJE)

- (a): As per the Report of the Expert Committee on Micro, Small and Medium Enterprises, constituted by Reserve Bank of India, the overall credit gap in the MSME sector was estimated to be in the range of Rs. 20 to Rs. 25 trillion as on June 2019.
- (b): The Government has undertaken a series of measures at the policy level to enhance credit flow and strengthen the MSME ecosystem in the country. These measures are as follows:
 - i. Ministry of MSME implements Credit Guarantee Scheme (CGS) for MSEs through Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) to provide credit guarantee for loans upto Rs 10 crore extended to new as well as existing MSEs without collateral security and third-party guarantee.
 - ii. Prime Minister's Employment Generation Programme provides Margin Money subsidy upto 35%, for setting up of new micro enterprises, in the non-farm sector with project cost of Rs. 50 lakh for Manufacturing and Rs. 20 lakh for Services enterprises.
 - iii. PM Vishwakarma Scheme was launched on 17.09.2023 to provide end-to-end holistic support to artisans and craftspeople of 18 traditional trades who work with their hands and tools. The Scheme includes provision of loans upto Rs. 3 lakh with interest subvention of max upto 8%.
 - iv. Self-Reliant India (SRI) Fund has been set up to infuse Rs. 50,000 crore as equity funding in MSMEs with a provision of Rs. 10,000 crore from the Government of India and Rs. 40,000 crore through Private Equity/Venture Capital Funds.

- v. The Emergency Credit Line Guarantee Scheme (ECLGS) was launched in May, 2020 as part of Aatmanirbhar Bharat Package to support eligible MSMEs and business enterprises in meeting their operational liabilities due to disruption caused by COVID-19 pandemic. The Scheme was operational till 31.03.2023. As reported by Department of Financial Services (DFS), under ECLGS, since inception till 31.03.2023, total 1.13 crore guarantees covering a value of Rs.2.42 lakh crore have been extended to MSMEs.
- vi. To bring Informal Micro Enterprises (IMEs) into the formal financial framework and enable them to avail Priority Sector Lending benefits, the Udyam Assist Platform was launched on 11.01.2023. Retail and wholesale traders have also been included under the MSME category for the purpose of Priority Sector Lending with effect from 02.07.2021. The Government has further extended non-tax benefits for a period of three years in cases of upward transition of MSME classification.
- (c): The year-wise and state-wise details of the last five years in connection with credit support extended to Micro, Small and Medium Enterprises (MSME) through major schemes of Ministry of MSME, such as Credit Guarantee Scheme (CGS) for Micro and Small Enterprises and Prime Minister Employment Generation Programme (PMEGP) are provided at **Annexure-I.** The Credit disbursed to MSMEs as reported by RBI during the last five years is at **Annexure-II**.
